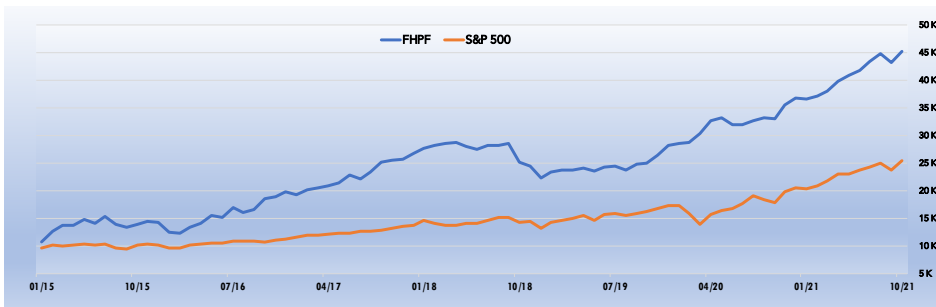


## Fountainhead Partnerships Fund (FHPF)

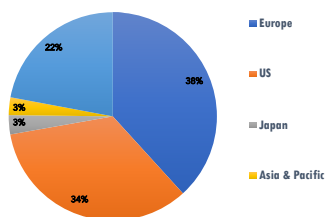

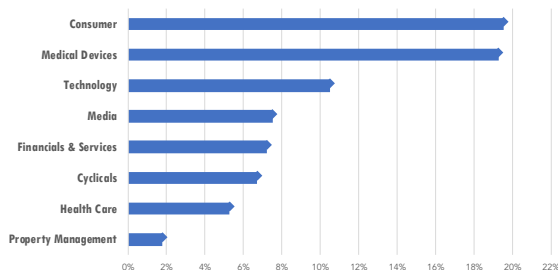
### GEOGRAPHIC EXPOSURE

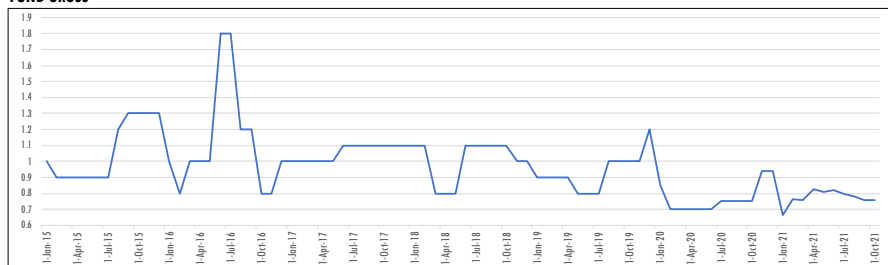
