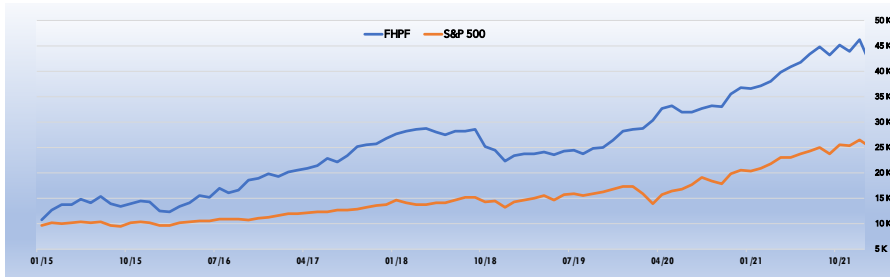


Fountainhead Partnerships Fund (FHPF)

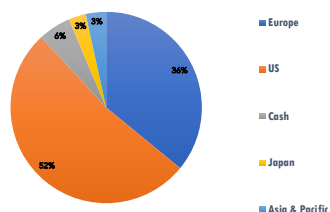

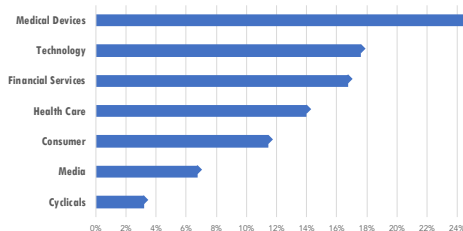
GEOGRAPHIC EXPOSURE

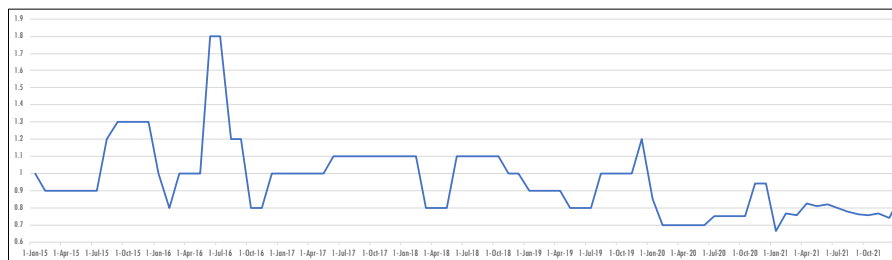
